The Committee formed will deal with:

1. Addressing the complaints regarding any misbehavior with women.
2. Implementation of security procedures and policies for women.
3. Providing helpline nos. and email ids for women.
4. Assisting the complainants and providing them with suitable solution and corrective actions.
5. Providing emotional support and counseling to the victims of sexual harassment.
6. To respect confidentiality of the complainant.
7. Investigating the cases and recommending action against offenders.
8. Counseling services for the students.
9. Conducting seminars on women safety.
10. Organizing special classes for self defense of the women.
11. Showing the short films addressing such problems and rights of the women.
12. Formation of student clubs focused on preventing sexual harassment and other related issues.
13. Appointment of Coordinators in the University buses to keep a check on the discipline in the buses, along with the policy to drop only male student or faculty on the last stop.
14. Providing information through banners and notices by displaying them in the campus and buses about the contact details of the members of Women Safety Committee and helpline numbers / email ids.
15. The Committee shall function as per the guidelines and norms laid down by the Hon'ble Supreme Court in Vishaka and Others Vs. State of Rajasthan and Others (Vishaka Guidelines)
